<u>Registration Update -</u> Approximately 100 registrations were processed since last month. We have approximately 970 players which is approximately 10% fewer than last year.

<u>Classic Committee Report</u> - The committee is seeking feedback on the updated version sent out. The document was reduced to policies and procedures only. Guidance material will be move to another document yet to be created. No major updates just changes to support the new classic policy and tryout procedures already approved.

Recreational Committee Report - No report submitted. Justin, Joann, Jodi and now Drew will look at the information available to coaches and see what they can come up with to provide more information. Jorge suggested including information to help coaches be more successful. Also attend a game or practice for the U-8's to explain in person about classic soccer to both the kids and the parents.

<u>Fundraising and Grants</u> -Justin reviewed the USSF Foundation criteria for grants and their program is structured for larger capital projects and as it is now we would not likely qualify. <u>Referee Scheduling</u> - Steve received instructions from Wayne to be able to cover along with Julie VanSambeek, while Wayne is on vacation.

Training: CCT - Steve Heaton has arrived and starting training this weekend.

Housing for him is completely arranged.

Coaching: Participation on the part of the U-8 teams with the CCT coach was much

lower than expected and very disappointing. Hopefully we can promote

these services more next year so we get better participation.

Miscellaneous: The first invoices for the services of the CCT coach will go out next week. Mike

has a template and will send them out.

<u>East Central</u> -Nothing new. The classic committee reviewed the details of the special committee to review the structure of the soccer season. Mike participated on this committee on behalf of KASA and it has yet to fully explain the reason for the committee. The classic committee submitted our strong objections to numerous issues that would result from the proposed departure of the current schedule.
